Conditions of Auction

- (1) The sale will be effected on the basis of inviting sealed quotations. A public auction will be conducted only if the sealed quotations do not fetch the reserve price fixed for the goods listed above. Interested parties for purchasing the items listed above, on an as is where is condition, can submit sealed quotations and participate in the public auction.
- (2) The bidders are to produce Electoral Card, Passport or Driving License as a proof of identity.
- (3) Sealed quotations superscribing "Quotation for purchase of old office furniture and other office equipments" are to be submitted to the Superintendent, PRO on or before 11.00 AM of 03.02.2012. Sealed quotations are to contain the bid amount and correct address of the bidder. The sealed quotations will be opened on 03.02.2012 at 11.30 AM at the Auditorium Hall of Central Excise Hqrs office, C.R.Bulding, I.S.Press Road, Cochin-682 018.
- (4) The participants of Quotation/Auction proceedings shall have to deposit Rupees 20,000/- (Rupees Twenty Thousand only) in the form of Demand Draft Drawn in favour of "Commissioner of Central Excise, Cochin" as Earnest Money Deposit on or before 11.00 AM of 03.02.2012 and should be submitted along with the Quotations. The said amount in respect of the successful bidder will only be retained and accepted by the presiding officer in lieu of advance sale price and the same will be adjusted from the final bid price of the successful bidder.
- (5) Sale will be effected to the person who quotes/bids the highest amount in sealed quotation or auction.
- (6) The goods will be sold on the assumption that bidders have inspected the goods and know what they are buying irrespective of the fact whether they have actually inspected the goods. The Presiding Officer does not give any guarantee or warranty or undertake any responsibility for the make, manufacture, description, quality, condition, size, weight, grade, accuracy or whatsoever of the goods.
- (7) No sale can be invalidated by reasons of any defect or fault in the goods or fault in the description/terminology in the Auction Notice.
- (8) All the tax liabilities whether State or Central Levy, on the purchase of the goods are to be met by the purchaser.
- (9) The successful bidder on 03.02.2012 after completion of Quotation/Auction process shall pay the full amount and the applicable taxes and take delivery of the goods or pay 25% of the bid amount (in cash – excluding the EMD of Rs.20,000/-) and take delivery of the goods subsequently – on or before 10.02.2012, Friday, after payment of the entire bid amount and the applicable taxes. If the successful bidder on quotation is not present at the closure of the auction proceedings, 25% of the bid amount will be collected from the next highest bidder. In the event of delay on the part of the highest bidder to remove the articles from the premises of this office, the office will not be responsible for any deterioration or destruction sustained to the said articles. If on the completion of auction, the successful bidder fails to pay the required money, the security deposit will be forfeited. The listed goods will then be offered to the next highest bidder or re-auction may be conducted at the discretion of the Commissioner.
- (10) The bidders are directed to give their correct names and detailed postal address. No name once given at the time of paying the EMD can be changed in the bid sheet. The delivery order shall be issued in the name given in the bid sheet only and be received by the person who signed the bid sheet at the time of auction.
- (11) The Presiding Officer in the auction reserves the right of removing any person for misbehaviour.
- (12) The Commissioner of Central Excise, Cochin reserves the right to reject any bid finally accepted in the Quotation/Auction proceedings or cancel the Quotation /Auction proceedings as such without assigning any reasons whether or not the bidder has paid the full amount.
- (13) Special conditions, if any, will be announced by the Deputy Commissioner (Preventive) at the time of auction.
